**International Shipping Agreement**

Definitions: "Ghanem Forwarding LLC": Ocean Freight Forwarder. "Customer": Person or entity applying for services. Ghanem Forwarding LLC agrees to provide, and customer agrees to receive the services of Ghanem Forwarding LLC according to the following terms and conditions:

By using Ghanem Forwarding LLC, I understand and agree to all terms of shipment. I certify that my shipments will not contain any unauthorized explosives, destructive devices or hazardous materials. I consent to search of any shipments. I am aware that this endorsement and original signature, along with other shipping documents, will be retained on file from the start of my business with Ghanem Forwarding LLC. I understand Titles will only be mailed to me upon specific request and after mailing fees paid. I understand freight payment is due by the shipment arrival date at destination per terms of invoice. I understand that Ghanem Forwarding LLC limits its liability to no more than \$50.00 USD per consignment. I understand I can elect to purchase additional Marine Insurance and that any binding coverage must be purchased prior to using any Ghanem Forwarding LLC booking and prior to US Port delivery. I understand that Ocean Carriers normally do not offer any coverages on cargo and limits their liability to their Bill of Lading Terms, which is usually no more than \$400 in case of total loss only.\*For Lagos, Nigeria shipments, I agree to pay all outstanding charges in full within 60 days of US Port manifest email, otherwise cargo is subject to auction automatically in Lagos to cover Ocean freight charges and I will still be held responsible for any additional charges for services requested in the USA.

1. Customer will use Ghanem services in a manner consistent with all applicable laws of the U.S. Federal Government.
2. Ghanem Forwarding LLC reserves the right, in its complete discretion, to deactivate the customer's Business account(s) upon an indication of credit problems including delinquent payments.
3. Customer agrees that all shipments do not include any hazardous, dangerous, or illegal materials. Customer hereby agrees to indemnify and hold harmless Ghanem Forwarding LLC for any claim resulting from the shipping of illegal materials.
4. Customer is responsible to verify the accuracy of ALL information listed on each dock receipt prior to the delivery of cargo to the terminal including: Carrier, Port of Loading, Foreign Port of Unloading, Consignee and Notify Party
5. Customer agrees to pay all costs incurred including: -Custom Rejections resubmission - \$50.00 per rejection  
 -Any special mailing expenses incurred (overseas packages, overnight / priority delivery, etc)  
 -Documentation & Handling fee's per vehicle as informed from Ghanem Forwarding LLC to customer
